The Specifications and Contract Documents for the above project are hereby changed or clarified in the following particulars:

GENERAL CLARIFICATION

- 1) The following questions were submitted by Plan Holders. The answers are as follows:
 - A. Question: Is 6x6-W1.4xW1.4 WWF per the UA Facilities Management Landscape Standards Drawing required for the 4" Concrete Trail?? Answer: Yes, add 6x6-W1.4xW1.4 WWF centered in the slab on Detail #5 on Sheet C3.
 - B. Question: Are the #4x18" dowel bars smooth or deformed #4 rebar on Sheet C3, Detail 5?

Answer: All dowel bars are to be smooth dowel bars.

- C. Question: Are the sleeves for the #4 dowel bars mentioned above to be speed dowels or plain sleeves? Answer: Plain Sleeves
- D. Question: Are the #3 x18" dowels smooth or deformed per detail 4A/Sheet C3? Answer: All dowel bars are to be smooth dowel bars.
- E. Question: Will silt fence be required along the entire sidewalk? Answer: Refer to the Stormwater Pollution Prevention Plan (SWPPP) included in the Bid Documents for sediment control plans.
- F. <u>Question:</u> Specifications Section 32 17 23, Part 2 PRODUCTS 2.1, A., B., & C; This spec only mentions Paint for pavement markings and does not mention thermoplastic marking at all. Sheet C3 of plans, Detail 6 states markings to be thermoplastic. Please Clarify

Answer: Thermoplastic markings will be required. Provide Thermoplastic Pavement Markings as per Arkansas 2014 Standard Specification for Highway Construction, Section 791.

G. Question: Sheet C3, Detail 6; Is the full length of trail to have thermoplastic center line or is center line to only be install in offsets?

Answer: Centerline Marking is only required at offsets as shown in the detail.

H. <u>Question:</u> On Sheet C2.0 & Sheet C3.0 Detail 2 indicates that asphalt pavers are to be used at crosswalk ramps. ** Per UA Standards should this be truncated concrete pavers walk?

<u>Answer:</u> Yes, replace asphalt pavers in Detail 2, Sheet C3 with truncated dome concrete pavers as per UA Standards, coordinate color with owner.

 Question: UL1 - Bega #8223P has been discontinued and is shown as a 120W-CF. Per NEW UA Campus Standards, this should be a Bega #7120 LED. Please confirm if the Bega #7120 LED fixture is to be bid in this project or provide alternate fixture.

Answer: Replace all Bega #8223P with Bega #7120 LED.
